When to use this form

Use this form if you (or a dependent child(ren) under 14 years of age) need to get an Individual Healthcare Identifier (IHI) and:

- · are not eligible for Medicare, or
- you are not eligible for a pension or benefit from the Department of Veterans' Affairs (DVA).

Individuals 14 years of age and over can request their own IHI using this form.

Important information

You will receive a letter to let you know the outcome of your application.

Healthcare Identifiers Service

The HI Service is a system that provides a consistent set of identifiers for individuals and healthcare providers. Healthcare identifiers provide a way to match the cornect record to the person being treated. This improves accuracy when health information is shared between healthcare providers.

The Healthcare Identifiers Act 2010 is available at www.legislation.gov.au

Healthcare identifier

A healthcare identifier is a unique 16 digit number that is assigned and used to identify everyone associated with healthcare in Australia. No clinical information is linked to the identifier. You do not need to remember your lift to receive healthcare.

If an IHI is being requested for a person under 14 years of age, it will be created using the address of the parent or guardian.

My Health Record

A My Health Record is an online summary of an individual's health information. It can be accessed at any time by the individual and their healthcare providers. You can get a My Health Record after you get your IHI.

Evidence of identity

You must provide 1 certified document from the Primary group or 2 certified documents from the Secondary group for each person applying for an IHI. The names in these documents must be identical. Documents provided must be current at time of application.

- photo identification card issued by the Commonwealth, state or territory government

- foreign government issued documents (for example, driver licences)
- · security quard/crowd control photo licence
- · consular photo identity card issued by DFAT

- Exhausted sick leave
- Undertaken paid work BUT cannot work due to wait for result

Who is this program for?

Applicants must meet all of the following:





be unable to access Commonwealth income support (including JobKeeper, Job Seeker and SRSS)



have zero or very limited income, savings or community support



be a temporary or provisional visa holder, or undocumented migrant

What support is being provided?

Limited cash payments to cover basic needs, such as food, bills and medicine. A single person may receive \$800. Families may receive more.

Red Cross can also provide information about other supports available to people living in Victoria on temporary visas.
